SUPPLEMENTARY / IMPROVEMENT EXAMINATION : 2026

SSSCE – 2026 (CBSE Std. XII) Supplementary Examination : 2025-26 will be held on 28.07.2026. Students declared as “Compartment” are eligible to appear only in one subject and who are declared as “Pass” can appear under the “Improvement of Performance” category in any one subject for which examination is conducted.

Regular students who appeared in Board Examinations 2025-26 through school with 6 subjects and placed in Compartment in two subjects are eligible to apply in any one of the two compartment subjects or, if declared Pass but could not clear one subject, can appear in the failed subject under the Improvement of Performance category only in the subjects for which examinations will be conducted.

Regular students who appeared in the Board Examinations 2025-26 and declared Pass can appear in any one subject under the Improvement of Performance Category only in the subjects whose examinations will be conducted.

Students are required to deposit **Rs. 320/- (Exam Fees)** through Bank Challan at the Odisha Gramya Bank (BJEM School Campus) and submit the challan at the **Academic Counter (Gate No. 02)** for online submission of LOC in CBSE Website. The last date for deposit of examination fee is **06.07.2026**.

N.B.: Students are also required to follow the eligibility criteria attached herewith.

ANNEXURE 1

FOR REGULAR STUDENTS	
ELIGIBILITY CRITERIA FOR SUPPLEMENTARY EXAMINATIONS 2026	
ELIGIBILITY CRITERIA: CLASS XII	
A.	Regular students who appeared in Board's Examinations 2026 through schools affiliated to the Board and declared as COMPARTMENT are eligible to apply only in one subject in which they are placed in the Compartment.
B.	Regular students who appeared in Board's Examinations 2026 through schools affiliated to the Board with 6 subjects and placed in COMPARTMENT in two subjects are eligible to apply in any one of the two subjects in which placed in the Compartment.
C.	Regular students who appeared in 6 subjects in Board's Examinations 2026 and declared PASS but could not clear one subject, can appear in the failed subject under the Improvement of the Performance category only in the subjects whose examinations will be conducted.
D.	Regular students who appeared in the Board's Examinations 2026 and declared PASS can appear in any one subject under the Improvement of the Performance category only in the subjects whose examinations will be conducted.
